THIS CAME TO MARCI'S ATTENTION AT 9PM THE NIGHT OF FRIDAY AUGUST 4TH WHEN MARCI CHECKED HER EMAIL AND FOUND ONE FROM DAWN WITH TWO WIRE TRANSFER RECEIPTS ATTACHED TO IT. MARCI IMMEDIATELY CHECKED THE CWA WELLS FARGO BANK ACCOUNT AND SAW FOUR WIRE TRANSFERS HAD POSTED BETWEEN JULY 25TH AND AUGUST 4TH. THE FIRST ONE DATED 07/26/2017 HAD BOUNCED BACK INTO THE CWA ACCOUNT, BUT THREE SUBSEQUENT ONES DID GO THROUGH TO THE TUNE OF \$54,192.09 IN TOTAL.
